## Model Induction Checklist for new governors

## Introduction

It is essential that all new governors feel welcomed into the school community and have the necessary information and support to fulfil their role with confidence.

This model checklist is not exhaustive, but gives examples of the key information and support that new governors should receive. Please note especially the importance of including safeguarding training as part of governor induction. This is good practice but likely to be made explicit in the next KCSIE 2022.

Please feel free to adapt the checklist to meet the needs of your own governing board.
