The RED is the new <u>Religious Education Directory (RED)</u> from the Catholic Bishops' Conference of England and Wales, with which Catholic schools must be in full compliance by **September 2025**. It covers Religious Education as delivered in primary schools and in secondary schools up to and including Key Stage 3. Many governing bodies have found it useful to assign the role of '*Training Link Governor*' to one of their governors, to promote governor development and to ensure governor training records are kept by the school. You may find our <u>model job description</u>, which you can use or adapt, useful as well as this <u>model template for reporting on individual training</u>.

Every school and academy must publish specific information on its website, including information about the governing body and trust board. Please note that a new section has been added to the DfE guidance which encourages schools and trust boards to collect and publish governing board and trust board diversity data What maintained schools must publish online What academies must publish online

DfE have updated their <u>non-statutory guidance on how to make the best use of pupil</u> <u>premium funding</u>. How does your governing body monitor the impact of pupil premium spend?

As you know, the Bishop's vision and the wider Diocesan plan is for all schools within our Diocese to become part of deanery based multi academy trusts.
